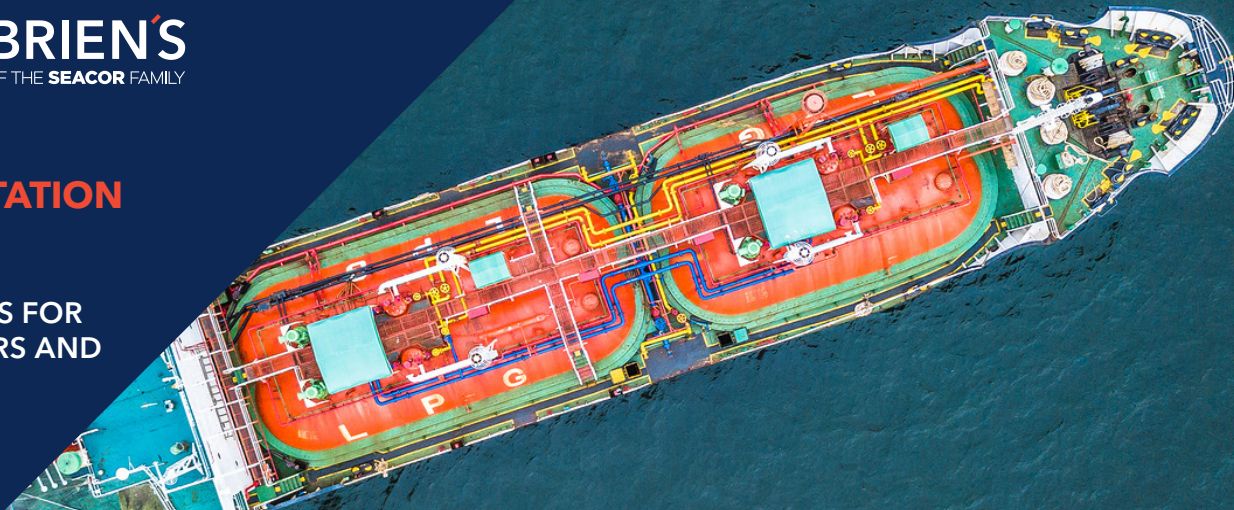

## REGULATORY ENFORCEMENT AND WHISTLE BLOWERS RAISE COMPLIANCE STAKES FOR VESSEL OWNERS AND MANAGERS

### CHALLENGE

Vessel owners and operators must comply with range of regulatory requirements that shift and grow over time. Port state authorities have intensified inspection protocols. Penalty assessments are on the rise, particularly with respect to MARPOL violations, ballast water management and low sulfur fuel oil requirements. To further complicate matters, recent precedents have incentivized whistle blowers.
